Dear Senator Gowan and Representative Cobb,

The Arizona Department of Administration (ADOA) is submitting the enclosed reports regarding the consolidated telecommunications budget and the Telecommunications Fund pursuant to A.R.S. § 41-712 and A.R.S. § 41-713.

ADOA anticipates State agencies will see additional charges from the telecommunications expense management contractor totaling \$959,600 statewide, equal to a 2.1% increase over FY 2022. This is related to a project currently underway to bring the State's multi-line telephone system into compliance with federal regulations for 9-1-1 capabilities.

ADOA receives less than 4% of the total telecommunication charges to administer the program, as shown in the report for A.R.S. § 41-712. The FY 2023 projections reflect what ADOA would typically receive, for year-over-year comparability. However, in keeping with our ongoing commitment to support agencies, ADOA is analyzing opportunities to minimize the impact of the cost increase by temporarily suspending ADOA's portion of the charges for several months this year. This voluntary revenue cut could offset a significant portion of the project costs in FY 2023. This can be accomplished responsibly because of the healthy cash balance in ADOA's Telecommunications Fund, as shown in the report for A.R.S. § 41-713.

**Arizona Strategic Enterprise Technology
Enterprise Infrastructure and Communications
Telecommunication Funding Source Report**

Pursuant to Arizona Revised Statutes § 41-712, the Arizona Department of Administration (ADOA) - Arizona Strategic Enterprise Technology (ASET) office is submitting an annual consolidated telecommunications report displaying contractor, carrier costs rate structure and payments made by state offices, departments and agencies for telecommunications services by agency and fund type for review by the Joint Legislative Budget Committee (JLBC).

Program Overview

Arizona Revised Statutes § 41-712 (Laws 2005, Chapter 301) directed ADOA to establish a Telecommunications Program Office (TPO) within ADOA for the oversight of a single statewide telecommunications network called AZNet. Offices, departments and agencies of the state enter into a contract through TPO for their telecommunication needs, including the installation and the maintenance of telecommunications systems. TPO is also charged with ensuring that its contractor acts as the State's agent for all carrier services to the offices, departments and agencies within AZNet.

In early 2011, TPO was part of a large technology group merger that included the Government Information Technology Office (GITA) and Information Services Division (ISD). The new technology-focused group was renamed the Arizona Strategic Enterprise Technology (ASET) office and became part of the Arizona Department of Administration (ADOA). As part of the creation of ASET there were four divisions created to ensure the continuity of operations: Strategic Transformation & Innovation (STI), Enterprise Capabilities & Delivery (ECD), State Data Center (SDC) and Enterprise Infrastructure & Communications (EIC).

EIC became the new division in charge of oversight of the single statewide telecommunications network called AZNet. EIC is responsible for entering into a primary contract for a contractor to provide for the installation and maintenance of telecommunication systems and to act as the state's agent for telecommunication carrier services to the offices, departments and agencies of this state.

During the initial phase of AZNet, the services agreement statewide telecommunications outsourcing was contracted between the State of Arizona and Accenture LLP. The next generation, AZNet II, was an agreement with CenturyLink to provide services to the state effective August 1, 2012, followed by AZNET III with CenturyLink/Lumen providing services to the state effective October 1, 2020.

Pursuant to Arizona Revised Statutes § 41-713, a telecommunication fund was established for paying costs incurred in operating the telecommunications program office. Revenues for this fund are derived from agencies in payment for services provided by EIC.

The fund consists of legislative appropriations; grants, except for otherwise specifically dedicated grants, received for telecommunication operations, consolidation and cost reduction or cost avoidance functions; monies derived from administering the telecommunications program office; monies derived from the sale or exchange of telecommunications assets or any assets that may be used to provide telecommunication access; monies derived from agencies, political subdivisions and other states or their agencies in payment for services provided by the telecommunications program office established pursuant to section § 41-712.

Program Report

Pursuant to Arizona Revised Statutes § 41-712 the department shall prepare and submit an annual consolidated telecommunications budget report to JLBC in connection with its annual budget request showing the previous fiscal year's actual payments and the next fiscal year's anticipated payments charged and received by the Telecommunications Expense Management contractor from state offices, departments and agencies for telecommunications services.

Monies derived from agencies and political subdivisions and other states or their agencies in payment for services provided by the telecommunications program office established pursuant to section § 41-712.

For FY23 estimates, the following assumptions were made: Carrier charges would remain similar; Shared Infrastructure charges will have an increase for the 911Inform Project, Voice and Network charges would remain as similar as possible with the AZNET III Contract that started on October 1, 2020. The TEM charge is reduced by \$60,000 due to new TEM contract and the EIC charge would remain a fixed monthly amount, with each agency's fee being assessed every month based upon the percentage of the agency's prior month spend; One Time Charges would materially be reduced, as no known projects have been anticipated; and, the Credits are an unknown amount as it is based upon the performance of the AZNet contractor.

**Arizona Strategic Enterprise Technology
Enterprise Infrastructure and Communications
Telecommunication Funding Source Report**

Pursuant to Arizona Revised Statutes § 41-713, The Arizona Department of Administration (ADOA) - Arizona Strategic Enterprise Technology (ASET) office is submitting an annual consolidated telecommunications report for review by the Joint Legislative Budget Committee (JLBC) that accounts for all monies deposited in the fund, the sources of the monies received for deposit, the purposes for which the fund monies were used during the preceding fiscal year and the plans for using fund monies during the next fiscal year.

Program Overview

Arizona Revised Statutes § 41-712 directed ADOA to establish a Telecommunications Program Office (TPO) within ADOA for the oversight of a single statewide telecommunications network called AZNet. Offices, departments and agencies of the state enter into a contract through TPO for their telecommunication needs, including the installation and the maintenance of telecommunications systems. The TPO is also charged with ensuring that its contractor acts as the State's agent for all carrier services to the offices, departments and agencies within AZNet.

In early 2011, TPO was part of a large technology group merger that included the Government Information Technology Office (GITA) and Information Services Division (ISD). The new technology-focused group was renamed the Arizona Strategic Enterprise Technology (ASET) office and became part of the Arizona Department of Administration (ADOA). As part of the creation of ASET, there were four divisions created to ensure the continuity of operations: Strategic Transformation & Innovation (STI), Enterprise Capabilities & Delivery (ECD), State Data Center (SDC) and Enterprise Infrastructure & Communications (EIC).

EIC became the new division in charge of oversight of the single statewide telecommunications network called AZNet. EIC is responsible for entering into a primary contract for a contractor to provide for the installation and maintenance of telecommunication systems and to act as the state's agent for telecommunication carrier services to the offices, departments and agencies of this state.

During the initial phase of AZNet, the services agreement statewide telecommunications outsourcing was contracted between the State of Arizona and Accenture LLP. The next generation, AZNet II, was an agreement with CenturyLink to provide services to the state effective August 1, 2012. The State is now in agreement with Lumen under AZNE III to provide services effective October 1, 2020.

Program Funding

Pursuant to Arizona Revised Statutes § 41-713, a telecommunication fund was established for paying costs incurred in operating the telecommunications program office. Revenues for this fund are derived from agencies in payment for services provided by EIC. See Table 1.

Program Report

Pursuant to Arizona Revised Statutes § 41-713, the department shall prepare and submit in connection with its annual budget request to the legislature, a report that accounts for all monies deposited in the fund, the sources of the monies received for deposit, the purposes for which the fund monies were used during the preceding fiscal year and the plans for using fund monies during the next fiscal year.
