Project Introduction



Overview of the approved original project investment justification (PIJ):

Business One Stop offers an alternative to the agency-based application process by providing users with a comprehensive business formation and management portal. On June 03, 2021, ADOA ASET approved the original project investment justification (PIJ) to build the Arizona Business One Stop solution. The first three phases of development were outlined. Having completed Phase I, the program is now moving into Phase II development and maintenance.

Phase I & Phase II

- In Phase I, the Program focused on tools that allow for the formation and maintenance of LLCs and the creation of trade names, trademarks, and tax licenses.
- In Phase II, the Program will focus on features that enable entrepreneurs to create and manage partnerships, trade names, and trademarks. The Program will also provide single-sign-on access to AZTaxes so business owners can manage their business' taxes. Finally, the Program seeks to integrate a new state-level agency within the portal.

The original PIJ covered Phase I work being completed from July 2021 - February 2022. A later change request completed in June 2022 requested an extension of the timeline to complete the Phase I work to June 2023. This Phase I work completed under budget (*\frac{1}{2}) IM) in June 2023.

Review Phase I



Major Accomplishments from Business One Stop Phase I Development

The Program identified several distinguishing highlights resulting from the Phase I development efforts.

- The Program released Business One Stop on August 24, 2022.
 - The website has processed 2,300 applications.
 - 97% of applications are started and submitted on the same day.
- Business One Stop offers users the ability to form 8 different business types: Limited Liability
 Company (LLC), Professional Limited Liability Company (PLLC), Sole Proprietorships, Limited
 Partnerships, General Partnerships, Domestic Limited Liability Partnerships, Domestic Limited Liability
 Limited Partnerships, and Foreign Limited Partnerships.
- Business One Stop is offered to entrepreneurs at no cost saving \$100s of pass through fees
- Business One Stop users can reserve trade names and trademarks and acquire tax licenses.
- Owners and authorized agents can **fully manage all lifecycle stages of LLCs and PLLCs** (planning, starting, running, and closing). Owners and agents can **access documents** critical to managing the business from the dashboard.
- **Instant approvals** have reduced the processing time of most applications. Previously, entrepreneurs were expected to wait 2-4 weeks for an approval/rejection of each application.

Lessons Learned



Lessons Learned in Business One Stop Phase I Development

Throughout Business One Stop Phase I development, the Program identified several risks that required cross-agency effort to control and remediate. Throughout Phase II development, the Program will be keenly aware of these risks and seek to proactively mitigate.

- Synchronized development of an interconnected system across five agencies proved to be challenging.
 - Agile project management was very difficult for some agencies to adopt and embrace scoping MVP, iterative releases, sprint tracking, etc were all individual challenges that needed to be tackled with each agency
 - Disconnected and disparate technology environments resulted in difficulties in development as well as testing and bug resolutions.
- Changes with other legislative prioritizes provided difficulty for overall roadmap planning of Phase I and Phase II development.
- Constraints with agency-partner contractors presented significant resource difficulties.

What in the PIJ is changing?:

- ✓ Budget Phase II Budget spend reduced from \$15,614,291 to \$6,500,000

 - Descoping of all work planned for ACC
 - Re-scoping work planned for DOR (replacement of features)
 - Adding work planned for SOS
- ✓ Timeline Project end date changing from June 30, 2023 to June 30, 2024

What initiated this change?:

- Budget The budget has been reduced to align with the changes in timeline and scope.
- Scope ACC and ADOR planned work was reduced as both agencies have conflicting legislature approved projects. ACC will replace their business registration platform (eCorp); and, DOR will replace its internal tax filing platform (AZTaxes). In lieu of planned features, DOR will be taking on a single-sign-on feature that connects B1S to AZTaxes. SOS has expanded their commitment to include the registration and maintenance of all partnerships, trade names and trademarks.
- Timeline Phase II development will end by June 30, 2024.



JLBC Approved Project Spend for FY2024




Update - High-level Phase II Project Timeline
