In response to the Change Request 0953 for the "**Business One Stop**" project, the Arizona Department of Administration (ADOA) Strategic Enterprise Technology (ASET) office has reviewed your proposal to add phase II to the project for Budget, Scope and Time.

- Budget - Phase II - Budget spend reduced from \$15,614,291 to \$6,500,000
- Scope - Phase II
 - Descoping of all work planned for ACC
 - Re-scoping work planned for DOR (replacement of features)
 - Adding work planned for SOS
- Timeline - Project end date changing from June 30, 2023 to June 30, 2024

The Change Request CR-0953 is scheduled to be **reviewed by ITAC on August 16, 2023** meeting. Should the ITAC approve the project, you may then proceed to secure additional approvals as required from the Joint Legislative Budget Committee, the Office of Strategic Planning and Budgeting, and the State Procurement Office.
