Project Introduction



Date/high-level overview of the approved original project investment justification (PIJ):

On 6/16/2023, ADOA ASET approved the original project investment justification (PIJ) to initiate the State Tax Accounting and Reconciliation System (STARS) Discovery and Planning Phase.

The STARS project will implement GCOM's RevHub software, an enterprise platform for tax administration and analytics. The project will begin with the Discovery and Planning Phase, which is scheduled for 18 months, 8/8/2023 - 2/7/2025. The STARS Project Team will use this time to:

- Develop and approve deliverables
- Deploy the initial software environments
- Plan the project phases in more detail
- Perform discovery and initial configuration planning

Prior to selection, the RevHub solution was evaluated by a cross-functional team which included city representation, to validate the product and functionality. The team made their recommendation and the solution was unanimously selected on February 22, 2023 and later approved by ADOA ASET and the Joint Legislative Budget Committee.

The original PIJ spanned 8/8/2023 - 2/8/2024 and had development costs of \$14,948,900.



The current PIJ Request RV23006 supports the scope and funding of the initial 6 months of the STARS Project Discovery and Planning Phase (8/8/2023 - 2/8/2024). The planned change request supports the scope and funding of the remaining 12 months of the 18 month Discovery and Planning Phase (2/9/2024 - 2/7/2025).

The existing STARS Project Milestones associated with the initial 6 months have been updated to align with GCOMs Project Strategy and Schedule documents. These milestones were originally developed prior to the completion of the contract award.

In addition, new STARS Project Milestones have been added to align with GCOMs Project Strategy and Schedule documents for the remaining 12 month period of the Discovery Phase.
