In response to the change request submitted to modify the Change Request (CR) for the "State Tax Accounting and Reconciliation System (STARS) Discovery and Planning Phase" project, it has been reviewed by the Arizona Department of Administration (ADOA) Strategic Enterprise Technology (ASET) office to expand the development costs, scope, and end date to accommodate the request of the FY24 appropriation in support of the remaining 12 months of the 18 month Discovery and Planning Phase.

The request includes: the development budget to expand from \$14.9 million to \$31.6 million, the end date to extend from February 8, 2024 until February 7, 2025, and the scope to include the remaining milestones of the 18-month Discovery Phase.
