Regarding the Project Investment Justification (PIJ) for the "Automated Traffic Management System (ATMS)" project, the Arizona Department of Administration (ADOA) Strategic Enterprise Technology (ASET) office has reviewed your proposal to integrate pump station status into ADOT's ATMS to improve severe weather response.

The PIJ indicates that Federal funding of \$2,418,540.00 is available for the project's total estimated five-year life cycle cost, as detailed below:
