Change Description (AS IS - TO BE)

With this change request, the ADOA-ASET project team is requesting a schedule extension and scope modification. ADOA-ASET is currently expanding the customer base for the Arizona Enterprise Services Platform (AESP). As the AESP platform development process and related projects have evolved, ADOA-ASET has determined that project tasks and milestones fall within the following two categories:

- 1. Implementation of a new service or feature
- 2. Onboarding of a customer to utilize a service or feature

With the intent to accurately reflect the project's ongoing development efforts, associated milestones, and status, the following scope changes are being proposed:

- · Update the milestones list and completion dates to represent individual milestones and progress in relation to the categories of Implementation or Onboarding
- · De-scope milestones no longer required due to current agency strategy or platform intent
- · Rename milestones due to software change or to match categories of Implementation or Onboarding
- Add new scope of work identified through customer interest in onboarding and security enhancements

The following detailed modifications to the scope and end date of the associated tasks and milestones are proposed. These project changes will be funded through current project budget allocations, with no additional funding required.

1 - Multi-Factor Authentication (MFA) Integration

Action requested: Rename - New name for milestone to be "Implement - MFA"

2 - Stratos Core High Availability Implementation

Action requested: De-scope - This milestone is no longer required. It has been determined that this milestone is not a viable solution to a past issue. A change in procedure was found to resolve the issue.

3 - Add Business Activity Monitor (BAM) Component

Action requested: Rename and extend completion date - End date change from 12/15/2015 to 3/31/2016. Business Activity Monitor (BAM) is no longer the most current software available for monitoring and logging. A newer option, Data Analytics Server (DAS), will be utilized. This is available from a vendor on State contract. The new name for this milestone to be "Implement - DAS".

Action requested: De-scope – Planning and development of this application is still ongoing. Another method or tool not yet identified will be utilized to achieve this goal. As a result, this task will be removed.
