MyDEQ Project - Phase 1 Arizona Department of Environmental Quality (ADEQ)

Automation of 13 business processes is planned for myDEQ Phase 1. ADEQ has completed and deployed one business process, QuickPay, which is now in production. In order to complete and deploy the remaining 12 business processes we are requesting changes to project end date as described below.

With this Change Request, we are seeking approval to amend the PIJ as follows:

1. Extend the project end date to January 30, 2015.

The following outlines the reasons for these requested changes:

- Bugs identified during UAT took longer than planned for debugging, fixing and regression testing.
- Setting up the environments are continuing to be more challenging than we had anticipated before.
- On WSO2's recommendation we had to change our Directory Server from ApacheDS to OpenLDAP.
- 1 new user story was added to the application. It was later decided by the Product Owner to not use those features.

Business Justification Summary

To make our web portal more robust and user friendly we must incorporate over 55 new user stories. Originally we had about 150 user stories. As these original stories were developed and demonstrated to the stakeholders, more user stories were identified which are now determined to be essential for Release #2 of myDEQ Phase 1. Our original scheduled date for Release 2 was 6/27. We are now expecting this release to occur on 9/30. We have released one Business Process (QuickPay) that allows our customers to pay their bills online.
