This is notification of Arizona Strategic Enterprise Technology Office's **Approval with Conditions** of the technology project as follows:

 Should development costs exceed the approved estimates by 10% or more, or should there be significant changes to the proposed technology scope of work or implementation schedule, the Agency must amend the PIJ to reflect the changes and submit it to ADOA-ASET, and ITAC if required, for review and approval prior to further expenditures of funds. 2. DHS may expand licensing for the project with ADOA-ASET approval, as long as the expansion does not modify the project scope of work, and an informational update is provided at the following ITAC meeting.

The amended PIJ is scheduled to be **reviewed by ITAC on August 12, 2020**. Should ITAC approve the project, you may then proceed to secure additional approvals as required from the Joint Legislative Budget Committee, the Office of Strategic Planning and Budgeting, and the State Procurement Office.
