## Director McKay,

In response to the Project Investment Justification (PIJ) for the "QNXT Upgrade and Trizetto Hosting" project, the Arizona Department of Administration Strategic Enterprise Technology office has reviewed the proposal to upgrade software used by the Department of Child Safety's Comprehensive Medical and Dental Program in order to bring the department in compliance with AHCCCS regulations and begin utilizing a cloud hosted environment.

The PIJ implies funding is available from Federal Funds in the amount of \$5,953.8 thousand for the total five year life cycle cost of the project, which is shown below.
