Director Jeffries,

In response to the Project Investment Justification (PIJ) for the "**2016 End User Device Refresh**" project, the Arizona Department of Administration Strategic Enterprise Technology office has reviewed the proposal to replace aging user equipment for a portion of the Department of Economic Security staff.

The PIJ implies funding is available from Base Budget General Funds in the amount of \$1,014.3 thousand, from Other Appropriate Funds in the amount of \$1,930.8 thousand, from Federal Funds in the amount of \$1,972.0 thousand, and from Other Non-Appropriated Funds in the amount of \$231.7 thousand for a total five year life cycle cost of \$5,148.9 thousand for the project, which is shown below.
