In response to the Project Investment Justification (PIJ) for the "myDEQ Phase 3" project, a meeting with the Arizona Department of Environmental Quality was held on 2/18/16 to consider your project to develop and deploy an additional 7 business processes to the myDEQ portal during Fiscal Year 2017 (FY17).
